C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

F. NON-JURISDICTIONAL WATERS, INCLUDING WETLANDS (CHECK ALL THAT APPLY):

- If potential wetlands were assessed within the review area, these areas did not meet the criteria in the 1987 Corps of Engineers Wetland Delineation Manual and/or appropriate Regional Supplements.
- Review area included isolated waters with no substantial nexus to interstate (or foreign) commerce.
 - Prior to the Jan 2001 Supreme Court decision in "SWANCC," the review area would have been regulated based solely on the "Migratory Bird Rule" (MBR).
- Waters do not meet the "Significant Nexus" standard, where such a finding is required for jurisdiction. Explain: Wetlands 1 4 on the site do not significantly affect the chemical, physical, and biological integrity of a TNW (i.e. the downstream portion of the Clackamas River).
 - There is a roadside ditch along the northeastern side of Sunnyside Road (off-site) which conveys hydrology from upslope wetlands and a stream downslope to Rock Creek. This wetland/stream/roadside ditch system does not contribute hydrology to the project site, nor does it receive hydrology from the project site.
 - There are no drainage patterns on-site that show the distinct flow of hydrology. However, the topography of the site suggests that water would flow downslope towards the western portion of the site. There is no ditch alongside 172nd Avenue or evidence of flow that suggests that hydrology leaves the site.
 - There is a stormwater inlet near the northwestern portion of the site (east side of 172nd Avenue) that connects to the storm drain system that may outflow downstream into Rock Creek. However, there is no significant nexus between the on-site wetlands and this stormwater inlet.
 - There is a stormwater inlet present near the northwestern portion of the site (southwest side of Sunnyside Road) that connects to the storm drain system that may outflow downstream into Rock Creek. However, there is no hydrologic connection between the on-site wetlands and this stormwater field drain.
 - Horizontal and vertical distance to the nearest water of the U.S.
 - 147 feet from Wetland 2 to stormwater inlet along 172nd Avenue (for this calculation we assumed a downslope flow to the property line, flow along the property line, across the sidewalk and into the inlet. Evidence of this flow was NOT present at the time of the Corps site visit). The vertical difference between Wetland 2 and this stormwater inlet is approximately 4 feet.
 - 113 feet from Wetland 2 to stormwater inlet along Sunnyside Road (for this calculation we assumed a direct line from wetland to inlet. This hydrology path is unlikely due to hydrology flowing across topography lines and was NOT observed at the time of the Corps site visit). The vertical difference between Wetland 2 and this stormwater inlet is approximately 3 feet.
 - The source of hydrology for the four isolated wetlands appears to be precipitation. There is no evidence on-site that hydrology from these wetlands leaves the site even during times of high precipitation.
 - Land between the wetlands and the two stormwater inlets is vegetated primarily with herbaceous species and some shrub vegetation (mostly Rubus sp.). A sidewalk and mowed vegetation strip is also present along 172nd Avenue.
 - Soil map units 13B and 70B are mostly non-hydric soil series, with hydric inclusions. Map unit 13B is characterized as being somewhat poorly drained, and having 20 to 30 inches to the fragipan restrictive feature. Map unit 70B is characterized as being somewhat poorly drained, and having 15 to 23 inches to the fragipan restrictive feature.
 - This site is not within or near a 100-year floodplain.
 - The site appears to be mowed regularly, but not farmed for agriculture. Therefore, these wetlands lack an interstate commerce connection.
 - Using the information above, the Corps has determined that Wetlands 1, 2, 3, and 4 are non-jurisdictional because they do not meet the "Significant Nexus" standard, where such a finding is required for jurisdiction.

Portland District Regulatory sent the AJD to Corps Headquarters on November 8, 2019 for review. Corps Headquarters responded on November 8, 2019 that they concurred with our findings.

Portland District Regulatory sent the AJD to the Environmental Protection Agency (EPA) on November 8, 2019 for review. EPA responded with comments on November 22, 2019, but did not elevate their review within the allotted timeframe. The Corps responded to the comments on January 6, 2020. The Corps is considering the agency coordination process complete.
