C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Ditch A: Ditch A is approximately 417 linear feet and is located in the northeastern portion of the study area and runs parallel to east/west portion of North Tie Road. Ditch A flows in a northwesterly direction and into a stormwater flow control vault located on the western end of Ditch A. The port of Longview is responsible for the operation and maintenance of the stormwater vault. Water flows beneath Industrial Way, eventually discharging to Cowlitz Diking Improvement District (CDID) Ditch Number 3, Ditch Number 3 flows to the Oregon Way Pump Station, which pumps the water to the Columbia River. Water flows during high precipitation events and hydrology inputs are primarily stormwater collection and conveyance systems as well as runoff from adjacent roadways. Vegetation within the ditch consists primarily of reed canary grass and there are no clear vegetation lines. Scour marks, wrack deposits, or erosion lines were not observed within the ditch. Based upon historic aerial photos the ditch was excavated in uplands. Ditches excavated in uplands, draining uplands, and carrying non-RPW flow are not considered waters of the United States.

Ditch B: Ditch B is approximately 254 linear feet and is located in the northwestern portion of the study area and runs parallel to the north/south portion of North Tie Road. Water within Ditch B flows in a northerly direction and into a culvert that joins with Ditch A prior to flowing into the stormwater flow control vault. Vegetation within the ditch consists primarily of reed canary grass and there are no clear vegetation lines. Scour marks, wrack deposits, or erosion lines were not observed within the ditch. Based upon historic aerials the ditch was excavated in uplands. Ditches excavated in uplands, draining uplands, and carrying non-RPW flow are not considered waters of the United States.

Perimeter Ditch: The Perimeter Ditch is approximately 281 linear feet and is located in the eastern portion of the study area and north of North Tie Road, and runs parallel to the east/west portion of North Tie Road. Water within the Perimeter Ditch flows through a culvert and outlets into Ditch A. Vegetation within the ditch consists primarily of reed canary grass and there are no clear vegetation lines. Scour marks, wrack deposits, or erosion lines were not observed within the ditch. Based upon historic aerials the ditch was excavated in uplands. Ditches excavated in uplands, draining uplands, and carrying non-RPW flow are not considered waters of the United States.
