# B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. If the aquatic resource is a wetland directly abutting a tributary with perennial flow, skip to Section III.D.4.

A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Corps districts and EPA regions will include in the record any available information that documents the existence of a significant nexus between a relatively permanent tributary that is not perennial (and its adjacent wetlands if any) and a traditional navigable water, even though a significant nexus finding is not required as a matter of law.

If the waterbody<sup>4</sup> is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. If the JD covers a tributary with adjacent wetlands, complete Section III.B.1 for the tributary, Section III.B.2 for any onsite wetlands, and Section III.B.3 for all wetlands adjacent to that tributary, both onsite and offsite. The determination whether a significant nexus exists is determined in Section III.C below.

#### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

- Does the tributary, in combination with its adjacent wetlands (if any), have the capacity to carry pollutants or flood waters to TNWs, or to reduce the amount of pollutants or flood waters reaching a TNW?
- Does the tributary, in combination with its adjacent wetlands (if any), provide habitat and lifecycle support functions for fish and other species, such as feeding, nesting, spawning, or rearing young for species that are present in the TNW?

- Does the tributary, in combination with its adjacent wetlands (if any), have other relationships to the physical, chemical, or biological integrity of the TNW?

Wetland A originates off-site south of the southern site boundary, and flows west into Ditch 1A. Due to drain tiles present on this site, surface flow from Wetland A and Ditch 1A appears to go subsurface where Ditch 1A becomes Ditch 1B. Hydrology surfaces again in Ditch 1C, likely due to soil alternations caused by the installation of a farm culvert. The dry sections of Ditch 1 (1B and 1D) have an ordinary high water mark and likely flow after storm events. There is a significant nexus connection between Wetland A, Ditches 1A, 1B, 1C, and 1D, and downstream waters of the U.S. Ditch 1D reaches a culvert under Highway 99E where it exits the northwestern corner of the site, then hydrology continues via ditches until it discharges into an old oxbow of the Pudding River. Wetland A and Ditches 1A, 1B, 1C, and 1D abut one-another and all have a surface connection to downstream waters of the U.S. Therefore, Wetland A and Ditches 1A, 1B, 1C, and 1D are waters of the U.S. Ditch 2 has an ordinary high water mark and vegetation present in the channel, although that is attributed to the ephemeral flow in the channel. Ditch 2 has a continuous surface connection to downstream waters of the U.S. Ditch 2 continues off-site north of the western project boundary, where it meets Ditch 1D flow and a culvert under Highway 99E, then hydrology continues via ditches until it discharges into an old oxbow of the Pudding River. Therefore, Ditch 2 is a water of the U.S.

### B. ADDITIONAL COMMENTS TO SUPPORT JD:

Ditches 3, 4, and 5 do not connect to or flow from another aquatic resources, were artificially created in uplands, lack a connection to interstate commerce, and do not have a significant nexus to downstream waters. During the February 26, 2020 site visit, a test datapoint was conducted between Ditch 3 and Ditch 1D and this area was confirmed uplands. Therefore, Ditches 3, 4, and 5 are considered isolated, and are not waters of the U.S.

Drain tiles are present on this site. Some of the drain tiles flow into the drain tile pond, others outflow into the ditches. There are two pumps on the site. The first is a groundwater pump located in the southwestern portion of the site which is enclosed in a white shed, and that pump is currently not in use. This pump in the past directed groundwater to an off-site pond located south of the site. There are no potential aquatic resources located in the vicinity of this groundwater pump. The second pump is located in the drain tile pond, which is used to pump water out for irrigation. The applicant does not know whether this pump is currently active. A small overflow pipe was installed between the drain tile pond and Ditch 1C, which appears to allow hydrology to flow from the pond to Ditch 1C if the pond was near the point of overtopping.

The Drain Tile Pond is present in the south-central portion of the site. Several drain tiles outlet into the pond and larger-diameter pipes from unknown sources feed into the pond. The pond is man-made, created in uplands, and does not have a natural surface connection to downstream waters of the U.S. There is a large pile of excavated soil next to the pond likely placed there during pond construction. Hydrology in this pond is primarily driven by drain tile outflow, and secondary hydrology may be from precipitation. Surface water runoff into the pond is unlikely due to the flat topography of the site. There was standing water present in the drain tile pond during the December 2018 field work and the February 26, 2020 site visit. The pond was created as a man-made reservoir for the irrigation system. There are no wetlands or streams coming into or out of this feature. Therefore, this feature is not a water of the U.S.

The Corps initiated coordination with EPA and Corps Headquarters on May 19, 2020. On May 29, 2020, EPA concurred with our conclusion via email. No response was received from Corps Headquarters during the 21 day coordination window. Therefore, the Corps is considering EPA and Corps Headquarters coordination complete.
