A stand-alone TNW determination should be completed following applicable guidance and should NOT be documented on the AJD form.

to do so. Corps Districts may, in case-by-case instances, choose to identify some or all of these waters within the review area.

⁵ Because of the broad nature of the (b)(1) exclusion and in an effort to collect data on specific types of waters that would be covered by the (b)(1) exclusion, four sub-categories of (b)(1) exclusions were administratively created for the purposes of the AJD Form. These four sub-categories are not new exclusions, but are simply administrative distinctions and remain (b)(1) exclusions as defined by the NWPR.

NWP-2020-127 Wetland 1	0.78 acres	(b)(1) Non-adjacent wetland	Wetland 1 is a palustrine emergent wetland located in the northern portion of the study area. This wetland flows west towards the western property boundary where the wetlands appears to flow off-site. There is an intermittent roadside ditch to the north of the project site which continues west along SE Vogel Road. The applicant has stated that Wetland 1 connects to a wetland off-site, west of the project site. This wetland is currently being filled as authorized by another Corps permit, and this wetland connects to the roadside ditch along SE Vogel Road. The roadside ditch that the downstream wetlands connect to was not constructed in a tributary, does not relocate a tributary, and was not constructed in adjacent wetlands. Therefore, this offsite ditch is not a jurisdictional tributary. There are no other aquatic resources adjacent to Wetland 1. Therefore, there is no direct hydrologic surface connection between the wetlands and an (a)(1) – (a)(3) water.
NWP-2020-127 Wetland 2	0.15 acres	(b)(1) Non-adjacent wetland	wetland. Wetland 1 is excluded under paragraph (b)(1), and is not a jurisdictional water of the U.S. Wetland 2 is a palustrine emergent wetland located in the southern portion of the study area. This wetland extends outside of the study area to the southwest, but per the applicant does not have a surface water connection to any other aquatic resources. Wetland 2 does not abut a territorial sea (a)(1), a tributary (a)(2), or an impoundment of jurisdictional waters (a)(3). It is not separated from a water identified in paragraph (a)(1), (2), or (3) only by a natural berm, bank, dune, or similar natural feature. It is not inundated by flooding from a water identified in paragraph (a)(1), (2), or (3) in a typical year. Wetland 2 does not meet the definition of an adjacent wetland. Wetland 2 is excluded under paragraph (b)(1), and is not a jurisdictional water of the U.S.
