Wetland 1 is a 0.35-acre palustrine emergent wetland located adjacent to an earthen spur road created during the construction of a municipal water line. Wetland 1 does not directly abut an (a)(1) - (a)(3) water, is not inundated by flooding from an (a)(1) - (a)(3) water in a typical year and is not separated from an (a)(1) - (a)(3) water only by a natural feature. Furthermore, this wetland is not separated from an (a)(1) - (a)(3) water only by an artificial structure allowing a direct hydrologic surface connection between the wetlands and the (a)(1) - (a)(3) water in a typical year. Wetland 1 is recognized as an excluded water pursuant to the (b)(1) exclusion of the Navigable Waters Protection Rule.
