This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. 2. **Characteristics of wetlands adjacent to non-TNW that flow directly or indirectly into TNW**

(b) General Flow Relationship with Non-TNW:

Flow is: **Intermittent flow**. Explain: As seasonal rains begin, the wetlands retain water until their capacity is reached. Surface water flows from Wetlands 1 and 3 flow offsite via a culvert under High Pass Road to the Long Tom River via Bear Creek. Surface water flows from Wetland 2 are supplemented by water pumped from the Long Tom River into the wetland by the property owner. Surface water flows from Wetland 2 would historically flow directly to the Long Tom River but a levee constructed in the mid-late 20th century prevents a direct outfall to the Long Tom River from Wetland 2. In absence of the man-made levee, floodwaters from the Long Tom River would reach all of the review area wetlands in a typical flood event.

Surface flow is: **Overland sheetflow**

Characteristics: Based on a review of aerial and ground-level imagery, surface water flows from Wetland 3 are directed through a driveway culvert to Wetland 1. Surface water flows from Wetland 1 are directed through a culvert under High Pass Road towards Bear Creek and the Long Tom River to the north. Wetland 2 has a historic hydrologic connection directly to the Long Tom River but is now separated by a man-made levee. Hydrology in Wetland 2 is also supplemented by an irrigation system which pumps water from the Long Tom River into the wetland for irrigation storage.

Summarize overall biological, chemical and physical functions being performed: These wetlands are located in an active, maintained agricultural setting and are regularly disturbed by agricultural activities. Wetlands 1 and 3 have a direct surface connection to the Long Tom River via Bear Creek and a culvert under High Pass Road. Wetland 2 is separated from a direct hydrologic connection to the Long Tom River by a man-made levee. The wetlands reduce the amount of stormwater and other non-point source pollutants that reach the Long Tom River.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

The review area is located entirely in Flood Hazard Zone A, in absence of the man-made levee, floodwaters from the Long Tom River would reach all of the review area wetlands in a typical flood event. The review area is located at an approximate 318 foot ground surface height and is described as being entirely located in Zone A, associated with the Long Tom River, as recognized by the Federal Emergency Management Agency (FEMA) Flood Insurance Rate Map (FIRM). Per FEMA, flood hazard areas identified on their FIRM's are identified as a Special Flood Hazard Area (SFHA). SFHA are defined as the area that will be inundated by the flood event having a 1-percent chance of being equaled or exceeded in any given year. The 1-percent annual chance flood is also referred to as the base flood or 100-year flood. SFHAs are labeled as Zone A, Zone AO, Zone AH, Zones A1-A30, Zone AE, Zone A99, Zone AR, Zone AR/AE, Zone AR/AO, Zone AR/A1-A30, Zone AR/A, Zone V, Zone VE, and Zones V1-V30. The review area location occurs in Zone A, a SFHA, as defined by FEMA which indicates the review area is located within an area subject to inundation by the 1-percent-annual-chance flood event generally determined using approximate methodologies.
