This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. #### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

	Aquatic Feature 1 within the Review Area is a pond, excavated from uplands, with non-RPW inlet and outlet ditches where upslope lawn irrigation runoff flows through the Review Area. Water flows from culverts under Highway 97 onto the site, entering Aquatic Feature 1. Water exiting the Review Area flows southwest under a roadway to where it enters into a culvert opening in an off-site shallow ditch channel. The channel runs parallel with the railroad tracks on the south side of the channel, flowing southeast and receiving flows from surrounding uplands until it reaches the A Canal 1.4 miles downstream. The ditch channel is recognized by the National Hydrography Dataset as a tributary. The A Canal (identified by the National Hydrography Dataset as an artificial path) is part of the Bureau of Reclamation's and Klamath Irrigation District's Klamath Project. The water from the canal enters a series of irrigation canals where it is applied directly to farmland. However, there are canal connections to the Klamath River.							
	The applicant provided photographic evidence of flow to the ditch channel. The pond appeared on the landscape sometime between 1956 and 1982. It created by the property owner for farm irrigation and animal watering purposes.							
	The National Hydrography Dataset does not show any tributaries flowing through the review area. Soils in the review area are upland.							
	Aerial imagery through time does not show signatures of flow paths through the area until upslope development occurs, creating impervious surfaces and lawn irrigation in the area. Also, aerial imagery shows the creation of the pond. In 2002 (post-upslope development), an aerial infrared image shows the pond outflow ditched portion of Aquatic Feature 1 as well. The pond is shown in aerials to be present approximately year round.							
	Water flow from the Review Area is in response to precipitation events and lawn irrigation and impervious surface runoff from upslope properties (to the northeast). The water flowing to the site is not from tributaries or wetlands. Water from the pond flows off-site only in response to larger storm events. The property owner confirmed that historically (before development above the inflow culverts), the pond dried up or at least was significantly reduced during summer months, resulting in the property owner curtailing irrigation. With increased impervious surface and irrigation of the upslope developed areas (evidenced on aerials showing green lawns surrounded by dry undeveloped areas), the feature only intermittently goes dry. The outflow from the pond ceases except when uphill summertime irrigation of lawns/landscaping surrounding the buildings and parking lots occur or when a significant storm event occurs.
