B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. Characterize tributary (e.g., water color is clear, discolored, oily film; water quality; general watershed characteristics, etc.).

Explain: In the on-site photos provided by wetland delineator, the surface water is relatively clear and most likely contains total suspended solids, such as sands and silts. The land use in the area currently is residential and agricultural, so the creek may have some contamination such as agricultural runoff and fertilizers. Overall, the Tualatin River watershed is relatively commercially and residentially developed.

Federally Listed species. Explain findings: According to U.S. Fish and Wildlife Service (USFWS) Information for Planning and Conservation Tool (IPaC), the following species are potentially affected by activities in this location: Pacific Marten (Coastal Distinct Population Segment), Marbled Murrelet, Northern Spotted Owl, Streaked Horned Lark, Fender's Blue Butterfly, Kincaid's Lupine, Nelson's Checker-mallow, and the Willamette Daisy. However, the project site does not possess suitable habitat for these species and is not utilized by the species.

Waible Creek is not recognized as designated critical habitat for these fish species or utilized by the species during their life history. Summarize overall biological, chemical and physical functions being performed: This is intermittent perennial stream. Surface water is present for extended periods especially early in the growing season, but is absent by the end of the growing season in most years. Characterized by erect, rooted, herbaceous hydrophytes, excluding mosses and lichens. This vegetation is present for most of the growing season in most years. This stream is usually dominated by perennial plants. There are no surrounding wetlands to buffer.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
