2. Non-regulated waters/wetlands (check if applicable):³

Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Two small features that meet 1987 Corps Manual wetland criteria are within the review area (Wetland A: 0.005 acre; Stormwater Swale 0.04 acre).

Wetland A is a small linear remnant of a former drainage swale (30 feet L X 8 feet W maximum dimensions; 0.005 acre) that is at least 120 feet from the RPW; there is no verifiable surface or sub-surface hydrologic connection to the nearest RPW (Wetland Ditch 1). The Wetland A is totally surrounded by uplands and was excavated in non-hydric soils. There is no visual surface or documented shallow subsurface hydrologic connection with the RPW.

In addition, an artificially created stormwater treatment swale (200 feet L X 10 feet W maximum dimensions; 0.04 acre) is located along the southwestern boundary of the site. The stormwater swale appears to have been constructed in 2012 when a temporary fire station was constructed on the property. The swale is located between a motel parking lot and the access road for the fire station. The temporary fire station was removed in 2014. The stormwater swale has not received stormwater inputs since the fire station was removed, but has maintained wetland hydrology because the swale was excavated approximately 6 – inches to 12 – inches, providing enough of a depression to collect overland flow and rain water. The outlet for the swale is at a higher elevation, requiring water to pond before reaching the elevation necessary to drain the site. The swale no longer receives runoff from upland impervious surface. Approximately half of the swale was constructed in non-hydric soil and aerial photographs prior to the construction of the swale do not show wetland hydrology signatures on the property. The stormwater facility is an artificially constructed swale.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are "relatively permanent waters" (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). A wetland that directly abuts an RPW is also jurisdictional. If the aquatic resource is not a TNW, but has year-round (perennial) flow, skip to Section III.D.2. A wetland that is adjacent to but that does not directly abut an RPW requires a significant nexus evaluation. If the waterbody⁴ is not an RPW, or a wetland directly abutting an RPW, a JD will require additional data to determine if the waterbody has a significant nexus with a TNW. If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. If the JD covers a tributary with adjacent wetlands, complete Section III.B.1 for the tributary, Section III.B.2 for any onsite wetlands, and Section III.B.3 for all wetlands adjacent to that tributary, both onsite and offsite. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:
