Explain: **Wetland B is a freshwater palustrine, forested, seasonally flooded/saturated depressional wetland that has no apparent surface water connections to the Yaquina River. Wetland B is separated from the nearest water of the U.S. (Yaquina River) by urban development including school building and parking lots; approximately 400 feet from the identified estuarine ditch/stream to the southeast (with building and high ground mounding, of stabilized dunes and fill**

material, separating the two features); and approximately 800 feet to the north directly to the Yaquina River (with development and infill separating the features). The source of hydrology for Wetland B is precipitation. Stormwater management plans provided by the applicant indicate an existing closed drainage basin to the north covering stormwater for the local building and parking areas. There is an existing 10" culvert that connects high ground to the north of wetland B to a catch basin north of an access road. During extreme rain events, there is the possibility that water from this catch basin could flow into Wetland B. There is not sufficient information available to determine whether Wetland B is a constructed stormwater management feature or a natural depression. The soils in the area of Wetland B are listed as Urban land-Waldport complex, and are hydric. Wetland B appears to be a poorly drained inter-dune depression situated between highly developed area, which would be consistent with the soil survey description for this complex. Waldport soils (present in some extent between Wetland B and the two closest connections to TNW's) are typically porous and excessively drained when not modified, but in this case there are urban development areas associated with the OSU Hatfield Marine Science center that surround Wetland B. Presence of these compacted fill areas, in combination with the distances to the Yaquina River and the presented geotechnical information suggest a lack of shallow subsurface hydrologic connection to the Yaquina River. Wetland B is outside of the mapped FEMA 500 year flood area. Information presented within the permit application and associated wetland delineation suggest the habitat within Wetland B would be most suited to various upland mammals. Ecologic isolation due to urban development would preclude any ecologic connection between Wetland B and the nearest water of the U.S. Wetland B has no history of industrial, commercial or recreational use associated with it..

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
