- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: There are two Palustrine emergent wetlands within the project area. Wetland A is 0.66 acres, Wetland B 0.08 acres, Wetland C is 0.06 acres.

This area was once the form Trogh Legacy Landfill which was used to dispose of construction and demolition wastes between 1966 and 1971. The location of the wetlands occurs near the abandoned runway (now used as a driveway) in a “benched fill area”, where non-native soils were deposited. This soil is relatively impervious causing ponding to occur in depressions. The Wetlands on the site are depressional features that perch rainfall on top of this fill material. The wetlands are not located in a mapped hydric soil unit.

Wetland A is a seasonally saturated water regime with scattered shallow ponding. Reed canarygrass is the dominate vegetation cover. Wetland A boundary was delineated using land form from slight concave wetland form to flat upland form. This change in landform also coincided with a change in vegetation.

Wetland B is just south of Wetland A. Wetland B is also a seasonally saturated water regime with scattered ponding. Wetland B is dominated by English hawthorn, balsam poplar, and slough sedge. Wetland B boundary was delineated using land form from concave wetland to flat upland. The adjacent upland soil lacked hydric soils.

Wetland C is just south of Wetland B. Wetland C is a palustrine emergent wetland. Reed canarygrass was the dominant vegetation in Wetland C. The wetland boundary was determined based on a change in the land form from concave wetland to a flat upland land form.

B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). Summarize overall biological, chemical and physical functions being performed: A sub-surface hydrologic connection was observed it is determined that this wetland shares a physical connection to TNW but does not support any overall function.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

This wetland has little to no relevance in flood storage for the area. The vegetation cover in the area is very minimal offering little to no habitat for herptiles or aquatic species. The tree cover is relatively non-existent causing low probability of offering the potential nutrients to downstream food webs. Although Wetland C does share a possible sub-surface hydrologic connection with the offsite drainage ditch, it is determined that Wetland C does not meet the criteria and therefore does not have significant nexus with a TNW.

C. SIGNIFICANT NEXUS DETERMINATION
