C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Wetland on site is hydrologically isolated from the nearest tributary (Butternut Creek) to a traditionally navigable waterway (Tualatin River). The wetland is approximately 0.08 acre in size, PEM. The wetland is physically situated approximately 0.13 miles to the NE from Butternut Creek. No surface or subsurface hydrologic connection is present, preventing any conveyance or contribution of water, sediments, organic matter, food resources, or other nutrients. Due to past construction activities in the surrounding residential area, the north end of the property that abuts SW Loma Vista St., as well as the NW portion of the property in the corner of SW Eaker Place and SW Loma Vista St. has been disturbed and graded in such a way that there is a 5 to 10-foot berm that prevents any hydrology from leaving the site. There are no culverts or outlets on the north and northwest sides of the property. Site is surrounded by residential development that has been present for over 10 years. Vegetation at the southern end of the wetland was predominantly meadow foxtail (*Alopecurus pratensis*), tall fescue (*Schedonorus arundinaceus*) and soft rush (*Juncus effusus*). The northern portion of the wetland adjacent to SW Loma Vista Street was primarily bare ground. This area was a steep cut bank and heavily disturbed. The eastern portion of the northern half of the property contained a shrub layer consisting of English hawthorn (*Crataegus monogyna*) and Himalayan blackberry (*Rubus armeniacus*). There were a few Digger pines in the northeast corner, above the cut slope associated with Loma Vista. Wetland plots had hydric soils meeting the redox dark surface (F6) and Depleted Matrix (F3) indicators. The primary hydrology indicator documented during the April site visit was soil saturation. Sources of water appear to be roof drains from the house, direct precipitation and perched conditions. The area within the wetland had clayey soils. The adjacent upland had similar vegetation however lacked the hydric soil indicators and hydrology. There is no Significant Nexus to a Traditionally Navigable Water.

Based on vegetation, soil and hydrology one 0.08acre PEM sloped wetland was identified onsite, delineated by Schott and Associates. This wetland location appeared isolated from a review done remotely via internet and from information provided by the applicant. A site visit was necessary to determine the location and proximity of the nearest WOUS to the wetland being considered for fill. The site visit was conducted on December 15, 2015 in the late morning where the weather was cloudy with light drizzle. The Local Wetland Inventory for the City of Beaverton was completed in 2001 and does not indicate the presence of any wetlands located on the subject site.

The 1.24 acre site is rectangular in shape, located in an urban neighborhood and surrounded by residential housing on all sides. A house, associated outbuilding and landscaping occupy the southern half of the property. The southern half is moderately sloped to the north and southeast. The northern half is a vacant plot dominated by grasses, shrubs and a few larger trees located in the northwestern corner. The southern half of SW Eaker Place (road) and the house on the site were present in the Google earth June 1994 aerial image. Additional housing to the east and south were present prior to 1994. More housing to the north and west began construction in 2005. SW Eaker Place (road) turned into a sidewalk which extended north to SW Lorna Vista Street during this time frame. The western border of the property adjacent to SW Eaker Place is lined with larger boulders and is approximately 5 to 10 feet higher in elevation than the adjacent sidewalk. The southern half of the property associated with the house has a maintained landscape. The northern half of the property remains undisturbed outside of yard clippings deposited on-site. The northern portion of the property is sloped to the north with an approximate 8% slope extending to SW Lorna Vista Street.

The wetland was located within the northwestern corner of the site extending from the middle of the property to the north adjacent to SW Lorna Vista Street. Vegetation was predominantly mixed grasses. Vegetation at the southern end of the wetland was predominantly meadow foxtail (*Alopecurus pratensis*) (FAC), tall fescue (*Festuca arundinacea*) (FAC) and soft rush (*Juncus effuses*) (FACW). The northern portion of the wetland adjacent to SW Lorna Vista Street was primarily bare ground.

Hydrology was present as surface water or saturation within the pit, derived from roof drains, direct precipitation and perched conditions. The eastern portion of the northern half of the property was slightly different in the vegetation community with a shrub layer consisting of English Hawthorn and Himalayan blackberry. There were a few Digger pines in the northeast corner, above the cut slope associated with Lorna Vista. The nearest Water of the United States is Butternut Creek, approximately 0.13 acre away to the southeast. There were no outlets present on the site and there is a berm (5 to 10 feet higher) along the northern boundary where the wetland is unable to drain from its location. This area was a steep cut bank and heavily disturbed.
