### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

The wetland delineation identifies a 0.08-acre seasonally inundated palustrine forested wetland within the 0.22-acre property tax lot. The wetland is located on the northeast corner of the property and abuts a seasonally inundated palustrine forested wetland complex which extends offsite to the east and north. These wetlands are considered relatively permanent waters which maintain a hydrologic surface connection with the west fork of Gross Creek. Gross Creek is a perennial waterway which possessess a bed, banks, and ordinary high water mark. Gross Creek flows north from the project area and maintains a hydrologic surface connection with the Coquille River estuary, a navigable water of the U.S. The Corps has determined the wetland in question possesses positive indicators of wetland hydrology, vegetation, and soils and is connected to a larger block of wetland which maintains a hydrologic surface connection with Gross Creek.
