### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:**

**Wetland D:** Wetland D is a 0.93-acre palustrine emergent wetland. Vegetation within the wetland is dominated by tall fescue (*Schedonorus arundinaceus*), Kentucky bluegrass (*Poa pratensis*), and meadow foxtail (*Alopecurus pratensis*). Wetland D extends beyond site boundaries to the north was previously delineated as part of NWP-2017-433. Stormwater system maps provided by the Port of Portland indicate that drainage from Wetland D is routed through a culvert that runs underneath the runway and then exits into the Glencoe Swale through a culvert located at the eastern end of Wetland B (beyond site boundaries). The Glencoe Swale flows into McKay Creek, flows in Dairy Creek and then flows into the Tualatin River. Flows from Wetland D contribute to the chemical, physical and biological integrity of the Tualatin River. Wetland D ponds with surface water runoff trapping potential floodwaters downstream and recharges the groundwater that sustains riverine base flows. Wetland D also traps and transforms pollutants (runoff) containing in overland flows from the surrounding area. Organic material and seeds would be temporarily trapped and transformed prior to being exported downstream. These functions improve water quality in downstream waters. Wetland D may also provide habitat for aquatic organisms such as frogs and salamanders that spend a portion of their lifecycle in wetlands and rely on nonwetland waters for other portions of their lifecycle.

**Wetland M:** Wetland M is a 0.039-acre palustrine emergent wetland. Vegetation within the wetland is dominated by tall fescue (*Schedonorus arundinaceus*), Kentucky bluegrass (*Poa pratensis*), and slender rush (*Juncus tenuis*). During precipitation events ponded water within Wetland M would flow to Wetland N and then into Wetland D through the culverts (described in Wetland N below). Wetland M ponds with surface water runoff trapping potential floodwaters downstream and recharging the groundwater

that sustains riverine base flows. Ponding occurs within Wetland M until the water overtops the bank and spills into Wetland N. Wetland M also traps and transforms pollutants (runoff) containing in overland flows from the surrounding area. Organic material and seeds would be temporarily trapped and transformed prior to being exported downstream. Flows from Wetland M would contribute to the integrity of the Tualatin River.

**Wetland N:** Wetland N is a 0.018-acre palustrine emergent wetland. Vegetation within the wetland is dominated by tall fescue (*Schedonorus arundinaceus*) and Kentucky bluegrass (*Poa pratensis*). Twin culverts are located between Wetland N and Wetland D that allow for surface water connection between the two wetlands. Wetland N ponds with surface water runoff trapping potential floodwaters downstream and recharging the groundwater that sustains riverine base flows. Wetland N would also traps and transform pollutants (runoff) containing in overland flows from the surrounding area. Organic material and seeds would be temporarily trapped and transformed prior to being exported downstream. Flows from Wetland N would contribute to the integrity of the Tualatin River.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Wetland L is a 0.014-acre palustrine emergent wetland. Vegetation is dominated by meadow foxtail (*Alopecurus pratensis*). Primary hydrologic inputs are direct precipitation, lateral subsurface flows, and surface runoff. There are no surface outlets connecting the wetland to downstream waters. Based upon the size and lack of connectivity to downstream waters, Wetland L does not contribute significantly to the integrity of the Tualatin River. Wetland L does not support interstate or foreign commerce.

On August 28, 2019 we coordinated this JD with EPA Region 10 and Corps HQ. On September 18, 2019 the EPA concurred with our findings. Corps HQ did not provide any response within the required timelines.
