B. REQUIRED ADDITIONAL COMMENTS TO SUPPORT JD. EXPLAIN RATIONALE FOR DETERMINATION THAT THE REVIEW AREA ONLY INCLUDES DRY LAND: No aquatic resources were found in the review area using the eGIS layers. Google aerial imagery shows a forested area and a grassy lawn. There are not any flow paths to the Siletz River or wetland signatures on the landscape. It appears to be only uplands in the review area. Additionally, the soil survey showed well drained soils. There are only uplands in the review area.
