C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

The tributary is approximately 325 linear feet long with an average of 7 feet wide and depth of +0.25 foot to +2.5 feet within scour pools. The National Wetland Inventory (NWI) map does not list wetlands adjacent to this tributary on this reach. The tributary would provide habitat and provide lifecycle support to fish and other urban wildlife species in the area. The tributary has a well defined riparian cover down to the confluence with Springbrook Creek providing a wildlife corridor, the corridor extends to the Willamette River. The well defined riparian cover would contribute organic material to the tributary, supporting downstream foodwebs. The tributary is intermittent and seasonally flooded providing water flow to the downstream Springbrook Creek and Willamette River. The effects to the TNW are not insubstantial or speculative.
