**Ephemeral Ditch 1: This feature is 582 linear feet in size within the review area. The ditch is comprised of two segments as shown in the figures. The ditch was excavated in uplands as shown in historic and current United States Geological Survey (USGS) maps.**

Lack of maintenance results in a very subtle features less than one-foot deep which lack defined bed and banks. The ditch does not connect downstream directly or indirectly to a TNW. The feature did not meet the criteria for a wetland.

**Ephemeral Ditch 2:** This feature is 263 linear feet in size within the review area. This feature is a remnant scar of a previously upland excavated irrigation ditch. The feature does not connected directly or indirectly to a downstream TNW. Over time and lack of maintenance has resulted in the ditch losing bed and bank. This remnant feature did not meet the criteria for a wetland.

**Operations Ditch 1:** This feature is 461 linear feet in size within the review area. The ditch was excavated as part of the closed-loop stormwater and water processing system for Sunny Valley and Gravel operations. The ditch does not flow directly or indirectly to a downstream TNW. The ephemeral ditch is excavated wholly in and drains only uplands, lacks relatively permanent flows and drains internally to mining Cell Two.

**Operations Ditch 2:** This feature is 1,657 linear feet in size within the review area. The ditch was excavated as part of the closed-loop stormwater and water processing system for Sunny Valley and Gravel operations. Operations Ditch 2 effectively infiltrates waters into the gravelly substratum. The ditch does not flow directly or indirectly to a downstream TNW. The ephemeral ditch is excavated wholly in and drains only uplands.

**Operations Ditch 3:** This feature is 1,707 linear feet in size within the review area. The ditch was excavated as part of the closed-loop stormwater and water processing system for Sunny Valley and Gravel operations. The ditch connects with Operations Ditch 2. The ditch does not flow directly or indirectly to a downstream TNW. The ephemeral ditch is excavated wholly in and drains only uplands.

**Depression T2-P1:** The recently created 0.07-acre depression is situated within road fill terraces (approximately three feet deep) which act as an impoundment to road runoff. Despite the 2012 upland conditions, this feature now satisfies all three wetland parameters. Vegetation is primarily dominated by *Danthonia californica* and *Juncus tenuis*, satisfying the Dominance Test for hydrophytic vegetation. Soils are observed to contain variable amounts of redoximorphic feature formation within the silt loam / silty clay loam soil to qualify for the Redox Dark Surface (F6) hydric soil indicator. Hydrology is primarily driven by precipitation and road runoff which is impounded within the subtle feature. This feature is not located near a jurisdictional tributary, and is located near Operations Ditch 3. This feature is a water filled depression resulting from construction. The site has not been abandoned, and therefore the feature is not a water of the U.S. This is consistent with the *Final Rule for Regulatory Programs of the Corps of Engineers* posted to the Federal Register November 13, 1986, whereas water-filled depressions related to a construction activity are generally not considered waters of the U.S..

**Remnant Borrow Pits 1, 2, and 3:** Pit 1 is 0.03-acre, Pit 2 is 0.07-acre, and Pit 3 is 0.14-acre. The pits are classified as palustrine emergent. Pit 1 is approximately 125 feet from Graves Creek, Pit 2 is approximately 217 feet from Graves Creek, and Pit 3 is approximately 110 feet from Graves Creek. Pits 1 and 3 occur within the FEMA mapped 100-year event. The borrow pits were dug in uplands for exploratory purposes in obtaining gravel. The pits are considered water-filled depressions incidental to construction, the site has not been abandoned, and therefore the pits are not waters of the U.S. . This is consistent with the *Final Rule for Regulatory Programs of the Corps of Engineers* posted to the Federal Register November 13, 1986, whereas water-filled depressions related to a construction activity are generally not considered waters of the U.S..

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. ### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**
