Summarize overall biological, chemical and physical functions being performed: The onsite wetland would provide minimal stormwater filtering for water running off from the site as the soils are gravelly. The site would not likely contribute detritus to the downstream TNW due to location of wetland and distance to TNW. There is no wildlife corridor along the wetland and animals were not observed in the wetland. Within the 75 acres considered in the cumulative analysis there were no other wetlands identified along the reach. The reach is all properties along the storm water drain which would drain to the same stormwater path. This area is entirely industrial development.

**C. SIGNIFICANT NEXUS DETERMINATION**

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

The depressional wetland measures 0.02 acre on a 2.13-acre lot. Wetland 1 is located in the northwest corner of the property. This wetland would capture overland sheet flow from the vacant property site of 2.13 acres because the site slopes to the north. From the wetland, any water flowing offsite would enter a public storm drain system (non-RPW) in Vista Avenue SE located approximately 25 linear feet north of the wetland. The public storm drain is piped until it enters an unnamed ditch (Non-RPW). This unnamed ditch eventually outfalls into Pringle Creek (RPW), then to Willamette River (TNW). The watershed of the drainage area for Pringle Creek is 73.02 acres.

The site is located in an industrial area. The overall site has a gravel surface in most areas along with other construction related debris from past operations. Onsite soils are highly compacted. The property has been vacant for several years.

There are no other mapped wetlands mapped along the path of the storm water system which would contribute water to the non-RPW along this reach. Water would only flow from the wetland to the storm drain during heavy rain events when the amount of water falling is greater than the amount of soil saturation. Any water flowing from the site would enter the storm water system at that point. There is 3,075 linear feet of piped storm drain and 4,200 linear feet of open unnamed ditch prior to any connection to Pringle Creek. The wetland has a low potential for flood storage as the soils are gravelly fill. There would be a low chance of organic debris, biomass, or food for fauna being transported from the wetland to the TNW due to the distance and flow path of the non-RPW and RPW. There is no wildlife corridor along this wetland that connects to the TNW. The site is not likely large enough to support the entire lifecycle of species which would use the

wetland for habitat or food nor is there access to nearby wetlands. The site does not support fish or shellfish. The project is not located in a floodplain.

The wetland would not serve in interstate commerce.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:**

The northern portion of the delineated wetland is the lowest and primarily vegetated with common spike rush (*Eleocharis palustris*) and thick-head sedge (*Carex pachystachya*) with approximately 40% bare ground and is covered on the east and west by approximately 2 feet high side slopes covered in Himalayan blackberry (*Rubus armeniacus*). Further south in the wetland is dense-flower willowherb (*Epilobium densiflorum*) and common spike rush. Two small Oregon ash (*Fraxinus latifolia*) shrubs are present in the wetland along with two small piles of rock. Soils consisted of gravelly fill soils, however hydric soil indicators were observed in the surface few inches.

This wetland appears to have been excavated in the early 2000's based on aerials.

The City's storm drainage map shows the following - from the northwest corner of the site there is 3,075 linear feet of piped storm drain to the outlet into an open channel identified as the East Fork Pringle Creek on the City's map. In most locations upstream of Walling Pond the channel is more accurately described as a roadside ditch. The dashed line on the storm drainage map is an open channel that flows through Walling Pond to the confluence with Pringle Creek. The open channel/ East Fork Pringle Creek flows 4,200 linear feet before the confluence with Pringle Creek.
