C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The study area is an undeveloped 1.02 acres field surrounded by impervious roadway and parking lots to the north, south and west and an apartment complex to the east. There are no surface waters within a 0.25 mile radius. The nearest surface waters are the Albany-Santiam Canal located 0.25 mile south of the study area and Periwinkle Creek, located 0.66 mile to the east of the study area. Both Albany-Santiam Canal and Periwinkle Creek flow into the Willamette River between river miles 118 and 120, however, there is no direct or indirect flow path between the study area and either the canal, creek or river. The delineated area sits approximately three feet below the street and parking lot elevation. There are no culvert inlets, outlets or storm drains located within the 1.02 acre study area. There are two storm drains along the west side outside of the study area on paved roadway leading to parking lots, however, they are at an elevation such that the entire 1.02 acres field would need to be inundated with runoff from the adjacent impervious surfaces to a depth of more than three feet to enter these drains. In the event of that occurring, it is unlikely water would flow into the canal or creek due to the distance from these features. The site sits outside any FEMA flood zone.

Based on aerial imagery dated 26 July 2018 it appears that runoff from the roadways on the east and west enter the site while there is no visual indication that water flows from the site. The wetland is separated from the nearest water of the U.S., the Albany-Santiam Canal, by urban development including high density housing, roads and parking lots. The canal is an 18-mile long historic man-made structure that delivers municipal water drawn from the Calapooia River approximately 2.7 miles distant and which discharges to the Willamette River. The source of hydrology for the wetland appears to be a combination of precipitation and adjacent impervious surface. There is no indication that the wetland alone or in combination with the nearest open water of National Wetland Inventory (NWI) mapped wetland have a significant effect on the chemical, physical or biological integrity of the nearest transitional navigable water because connectivity has not been demonstrated between the study area and any downstream water.

NWI information collected with field reconnaissance from 13 through 19 February 1989 depicts an approximate 0.25 acre remnant of a larger 6.02 acre freshwater emergent persistent seasonally flooded wetland (PEM1C) isolated wetland at the south end of the study area, however, the delineation is consistent with the more recent Local Wetland inventory with respect to this remnant potential wetland area. The National Hydrography Data map did not provide indication of surface connection to canal or creek.

An earlier delineated dated 9 June 1996 and prepared by Wetland Specialties, Inc. associated with NWP-1996-1205 reported historic agricultural drainage ditches in the vicinity of the current site. Photo interpretation shows these ditches were filled between 1944 and 1986 during residential development. No permit resulting from the delineation was issued.
