Dry Dock: The dry dock is 75 feet wide by 225 feet long and 14 feet high. It was constructed in the 1950's. At the confluence of the dry dock and Umpqua River is a gate. For operation purposes the gate would be opened at high tide, allowing water and vessels to travel into the dry dock. Once the vessel was secured it would sit until low tide. At low tide the water within the dry dock would drain and the gate would be closed. The top of the gate is located at 12.7 feet MLLW. In its original design, the gate of the dry dock when closed would act as an artificial barrier preventing a surface hydrologic connection between the Umpqua River and the dry dock.

33 CFR 329.8 (2) states “(2) The artificial waterbody may be a major portion of a river or harbor area or merely a minor backwash, slip, or turning area (see §329.12(b) of this part).”

33 CFR 329.8 (3) states “Private ownership of the lands underlying the waterbody, or of the lands through which it runs, does not preclude a finding of navigability. Ownership does become a controlling factor if a privately constructed and operated canal is not used to transport interstate commerce nor used by the public; it is then not considered to be a navigable water of the United States. However, a private waterbody, even though not itself navigable, may so affect the navigable capacity of nearby waters as to nevertheless be subject to certain regulatory authorities.”

Prior to Knife River purchasing the dry dock, it was owned by Douglas County, and before that it was owned by the Umpqua River Navigation. Umpqua River Navigation mined sand out of the river using barges with a clamshell crane. The sand was barged to the south side of the river where it was offloaded for processing. From there it likely went to local construction projects along the Oregon coast. The dry dock was used to conduct maintenance on the barges owned by Umpqua River Navigation. Based on this information, it is determined that the dry dock was not used as part of foreign and interstate commerce.

The dry dock is not tidally influenced nor was it used in the past or present in interstate or foreign commerce. The dry dock is a depression related to construction and has not been abandoned, therefore the dry dock is not considered a water of the United States.

If the tributary has adjacent wetlands, the significant nexus evaluation must consider the tributary in combination with all of its adjacent wetlands. This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
