Explain: **Review of the wetland delineation reflected two wetlands (L and M) are hydrologically isolated and do not provide flows to a traditional navigable waterway. The wetlands are located in fill material found along roadway ramps which ponds rain water in each depression. The wetlands likely formed as part of construction activities**

associated with the original construction of OR 217. The wetlands do not provide chemical or biological benefits to downstream waters. These wetlands are not used for commerce purposes. A total of 34 ditches were delineated within the review area and 33 were determined to have been constructed in uplands and do not drain or redirect flows of a water of the U.S.

### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The wetlands are fed by rainfall. Flows from wetland L and M do not continue downstream to the Tualatin River and are isolated on hill slopes along ramps.**
