### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** Wetland A and Senecal Creek Senecal Creek flow into Mill Creek, which flows into the Pudding River, which flows into the Willamette River (a traditionally navigable water).

Senecal Creek (7,748 sf/ 0.18 acres) has been altered and ditched to reside in its current location along the eastern property boundary. There was no flowing water present in the vegetated channel during the August field work, and according to USGS and StreamNet mapper, this reach of the creek is intermittent. The Cowardin classification is riverine, intermittent, vegetated streambed, seasonally flooded, partly ditched (R4SBCd) wetland, and Riverine is the primary HGM classification.

Wetland A (136,659 sf/ 3.14 acres) is adjacent to Senecal Creek and extends southwest across the field along the original orientation of the creek channel. The Cowardin classification of Wetland A is palustrine emergent-persistent, seasonally saturated, partly drained/ditched (PEMBd) wetland with a hydrogeomorphic (HGM) class of Slope.

Ditch 1 (700 sf/ 0.02 acres) runs along the south side of Le Brun Road NE and connects to Senecal Creek at the northeast corner of the tax lot.
