- Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.
Explain: **Wetland A, measuring 0.47 acre in size, is a palustrine emergent and forested (PEM, PFO) wetland located in a depressional area in the northeastern corner of the review area. The primary soil mapped for the review area is Rock outcrop-Xerumbrepts complex, and is not listed as a hydric soil according to the Columbia County hydric soils list.**

The hydrology source is from groundwater and a 12-inch diameter culvert that enters the site beneath McBride Street from the north, which seasonally drains stormwater runoff from McBride Street. There are no drainage features between Wetland A and the nearest water of the U.S. The stormwater does not drain or connect to any other waterbody, rather it terminates at Wetland A. The vertical elevation at the northeast end of Wetland A at McBride Street is approximately 108-feet above seal level, whereas the vertical elevation at the southeastern end of Wetland A is approximately 107-feet above sea level. The review area gently slopes to the east except for the depressional area located in the northeast corner of the review area. The wetland does not continue off-site.

Corps staff conducted a site visit on 13 November 2019 and confirmed there is no downstream connection to any waterbody, including stormwater drainage paths that could connect to another water. This observance is consistent with the information shown in the National Hydrograph Dataset (NHD), as accessed through the Portland District Corps of Engineer eGIS Information Portal. Milton Creek, which is the closest relatively permanent water, is approximately 0.5-mile from Wetland A. Two ephemeral drainages are shown on the NHD map located at or near Highway 30, which are to the south of the review area approximately 0.15 mile away. During the site visit it was determined there are no drainages exiting from Wetland A that connect to the ephemeral drainages. The area between Wetland A and Milton Creek is highly developed with over 90% impervious surfaces. There is no evidence Wetland A possess an interstate commerce connection to downstream waters.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
