Explain: **A 2.05-acre forested/emergent wetland was delineated onsite, mainly fed from direct precipitation and some drainage from the west. The emergent conditions are present on the western half and forested on eastern half.**

Historically the wetland continued to the east, but now it is severed by NW Aloclek Drive, which acts as a barrier to

movement of water. There was no culvert under the roadway and no ditches on any of the roads surrounding the property. The wetland is hydrologically contained onsite, with no outlets for water to continue offsite. There is no interstate commerce connection. There is no habitat, resources, or animals species which would attract interstate or foreign travelers; no fish or shellfish which could be taken or sold in interstate or foreign commerce; and no industrial, agriculture, or silviculture purpose.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
