East Santa Clara Waterway. The surfaces of the ponds is approximately 8 to 10 feet below the surrounding landscape. There are no wetlands or waterways providing hydrological flows to or from the ponds.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The Delta gravel ponds have no hydrological, biological, chemical, or physical connection to downstream waterways. The City of Eugene stormwater management plan (Book VIII Santa Clara) depicts the East Santa Clara Waterway stormwater facility to the West of the ponds, however there is no connection to the ponds according to the stormwater management plan. The ponds appear to be in the City of Eugene stormwater management plan (Book VI Willamette) which does reflect the

location of the pond being in this stormwater management area but does not reflect any storage or use of the ponds for stormwater. Aerial photographs of the ponds appear to show a potential “flow” of water from the ponds to the West and to the East Santa Clara Waterway. Upon further review of the corridor with street view, the green corridor is a lot of fir trees planted along the roadway and the farmers field to prevent dirt and dust from traveling into the landowners house and garden. Vegetation was not representative of hydrology presence and fir trees require a dryer root system to survive. The area between the ponds and the fir trees does reflect agricultural use and tractor till marks are seen in aerial photographs and the street view looking SE towards the ponds. Green grasses are observed on aerial photographs just West of the ponds, however the homeowner located to the Southwest of the pond waters his lawn and keeps his yard green. Some of the watering ends up supporting some of this green vegetation in this region. No culvert was observed within the pond and was not reflected in the delineation and no downstream connection was observed. The ponds were constructed by gravel extraction and were not filled back in with materials. Since the initial removal of gravel from these locations, the ponds have developed and remained. Side slopes of the ponds are 4:1. The USGS Maps of the review area reflect the use of the ponds as part of a mineral extraction site.
