Flows in this area go to the ponds and do not contribute to downstream flows. History of the ponds reflects they were created by gravel extraction processes for the construction**

of Interstate 5. The gravel pits filled in with water and have remained in this condition. Vegetation around the ponds appears to have forested wetland characteristics. A drive around the roadways along the site reflect the elevation of the surrounding areas is anywhere from 4 to 8 feet higher than the property and the ponds. There are ditches with signs of stormwater from the surrounding developments and roadways flowing to the ponds. The pond is an enclosed basin and is surrounded by highway 99 to the east, McDougal Lane to the north, Jessen Drive to the South, and Arnold Avenue to the west.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The site has been visited by Oregon Department of State Lands and in a letter dated 7 August 2019, the state determined they had no jurisdiction over the ponds and fringe wetlands. The site was visited by the Corps on 10 March 2020 to determine if flows could be conveyed from the ponds in a western direction to the Amazon Canal. The ponds are depressional in the landscape as a small catch basin with elevations as much as 10 feet above the surface of the ponds. Roadside ditches along the site in

the basin reflect flows going to the ponds and outside the basin the flows go the opposite direction. Approximately a 1/4 mile west from pond 2, the flows along Jessen Drive in the drainage ditch to the south reaches a point in the ditch at Arnold Avenue which is eight feet higher in elevation than the ponds which causes rainfall to either flow east off the roadway and to the ponds. If the rainfall flows west off Arnold Avenue the flows would continue towards Amazon Canal, which flows into the Long Tom River, and then into the Willamette River. Pond 2 is approximately 20 feet deep and Pond 1 is close to 10 feet deep. The ponds capture stormwater from approximately 100 acres of impervious surfaces in the surrounding area. The 10-year storm event in 2018 did not fill the ponds and cause stormwater flows to change directions to Amazon Canal. The ponds were used as gravel pits to extract gravels for construction of Interstate 5. The drainage basin area is bounded by highway 99 to the east, McDougal Lane to the north, Jessen Drive to the South, and Arnold Avenue to the west. Currently the property is owned by the Oregon Department of Fish and Wildlife.

The AJD was coordinated with EPA and HQ in an email dated March 24, 2020. No response was received from HQ during the 21 day review timeframe. The EPA concurred with the Districts findings in an email dated April 10, 2020. The AJD was finalized on the date shown on page 1.
