Explain: **Two palustrine emergent wetlands and a swale feature were delineated on site, with hydrology presumed to be provided by precipitation and a high ground water table. Wetland A is 0.21 acres on the eastern side of the study area approximately 1/8th of a mile from Mill Creek and Wetland B is 0.17 acres and the swale is 0.23 acres, both located on the western side of the study area approximately 1/6th of a mile from Mill Creek. The swale is an isolated**

pond separated from Wetland B by a berm. The swale shows a distinct ordinary high water mark and surface water that is also present historic aerial photos. Per the local wetland inventory, Wetland B and the swale historically drained off site, but drainage has been severed by development and the construction of Hawthorne Avenue NE. Wetland A is not shown on local or national wetlands inventories, and may have been created by road construction restricting drainage from the study area. Currently, the wetlands and the swale are hydrologically contained onsite, with no outlets for water to continue offsite. There is no habitat, resources, or animals species which would attract interstate or foreign travelers; no fish or shellfish which could be taken or sold in interstate or foreign commerce; and no industrial, agriculture, or silviculture purpose. There is no interstate commerce connection..

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The site is a 10.18 acre site, on tax lot 1300 on Marion County Tax Map 07 3W 36A. The site is located west of Interstate 5 and Hawthorne Avenue SE and south of Kettle Court SE. Mill Creek flows northwesterly off-site to the south. The waters at the site are approximately 880 feet from Mill Creek. Mill Creek possesses a bed, banks, and ordinary high water mark and is recognized as a relatively permanent water of the U.S. Mill Creek maintains a hydrologic surface connection with the Willamette River near river mile 85. The U.S. Army Corps of Engineers, Portland District recognizes the Willamette River as a navigable water to river mile 183.2

The majority of the site is currently being used for Douglas-fir Christmas tree production and fallow fields. The eastern side of the site has a small riparian forest surrounding a pond. A gravel road enters the site from Hawthorne Avenue south of the riparian forest. Wetland B and the swale are in soils mapped as hydric (Concord silt loam and Dayton silt loam). Wetland A is in soils mapped as non-hydric but with hydric inclusions (Amity silt loam). These soils are not excessively well drained such that subsurface flow would be expected. There is an HDPE culvert under Hawthorn Road NE to the east, but the wetlands and swale do not drain in the direction of the culvert or offsite through it. The lowest parts of the study area are within the 100 year floodplain, and the rest of the site is mapped as "other flood areas."
