Explain: A 200 linear foot, 1,382-square-foot engineered drainage ditch lined with rip-rap was determined to be not jurisdictional. As-built drawings from the City of Beaverton show the rip-rap drainage ditch as installed during reservoir construction. No wetlands or drainages appear in historic aerial photographs of the study area prior to construction. No wetland soils are present in the ditch, and flow is only in response to rain events. There is no evidence of any connection to other waters.

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The ditch in the review area was constructed in upland soils for the purpose of conveying runoff captured by the reservoir gutter drainage system. The ditch originates from a 24-inch concrete culvert, and the ditch is lined with rock for the entire onsite portion. The ditch substrate is angular rock (riprap) comprised of rock sized mainly 6 to 12 inches in diameter. The NRCS Web Soil Survey does not show any hydric soils in the study area. The National Wetlands Inventory does not show any mapped wetlands in the study area.
