Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional.

Explain: The 0.27 acre wetland within the Review Area is located in the southeastern corner of the property. The wetland receives surface water input from two discernable sources. Sheet flow collects into two catch basin grates near the center of the property and discharges from a culvert outfall into the northern boundary of the wetland. Additionally, the property employs fire suppression during the summer to minimize the natural combustion of large compost piles. As a result, excess

water drains into a 1,220 linear foot, 5 foot wide ditch located on the eastern side of the property. This ditch maintains a hydrologic surface connection with the northeast boundary of the wetland. Another ditch runs along the southern boundary of the property, but there is no discernable connection to the wetland or evidence of flow from the wetland into the ditch. The ditch along the southern boundary is not within the Review Area for purposes of this Jurisdictional Determination.

A site visit was conducted by the Corps on February 26, 2020, to verify the extent of wetlands and evaluate the movement of water throughout the features within the Review Area. The 1,220 linear foot ditch located along the eastern side of the property has a width of 5-6 feet and gradually increases in grade heading north. The contour of the ditch widens and becomes less defined at the north. There is no discernable connection from this ditch to another aquatic resource near the head of the ditch. The southern extent of the ditch connects into the 0.27 acre wetland. The southern boundary of the wetland was determined by a distinct change in elevation, shift in the vegetation community, and lack of hydrology. No evidence of flow was observed beyond the mapped wetland boundary within the Review Area. While the wetland provides stormwater retention for the property, there was no observed connection or movement of water from the wetland to the nearest RPW.

This significant nexus evaluation that combines, for analytical purposes, the tributary and all of its adjacent wetlands is used whether the review area identified in the JD request is the tributary, or its adjacent wetlands, or both. C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.
