Summarize overall biological, chemical and physical functions being performed: These three wetlands are palustrine emergent (PEM) wetlands which correspond to an area mapped in the Local Wetland Inventory (LWI) as "significant wetlands" and contribute biologically, chemically and physically to an RPW mapped on the LWI as "Glencoe Swale Trib." LIDAR imagery shows hydrologic connectivity between the wetlands and the RPW downslope, indicating that the wetlands have the capacity to moderate water flow to the RPW, retain sediments, provide habitat for terrestrial and avian species, and contribute carbon and nutrients to the RPW.

Wetland 1 is a 0.69-acre wetland with a slope hydrogeomorphic (HGM) class and a Cowardin classification of seasonally flooded/saturated, palustrine emergent (PEME). The wetland slopes south-southwest. The onsite vegetation community is composed predominantly of reed canary grass (*Phalaris arundinacea*; FACW) and soft rush (*Juncus effusus*; FACW), along with meadow foxtail (*Alopecurus pratensis*; FAC), tall fescue (*Schedonorus arundinaceus*; FAC), and colonial bentgrass (*Agrostis capillaris*; FAC). A stand of slough sedge (*Carex obnupta*; OBL) occurred in the lowest-lying portion of the wetland. The southwestern margin of the onsite wetland and the portions offsite to the south are vegetated by Oregon ash (*Fraxinus latifolia*; FACW) forest with a slough sedge understory.

Wetland 2 is a 0.03-acre wetland with a flats HGM class and a Cowardin classification of PEME that occupies the bottom of a shallow, southwest-sloping swale apparently bound by placed fill material. Wetland hydrology is driven by groundwater and the impoundment of precipitation within the topographic depression. The vegetation community consists of meadow foxtail, tall fescue, and a stand of teasel (*Dipsacus fullonum*; FAC).

Wetland 3 covers 334 ft<sup>2</sup> and occurs within a small topographic depression in the north-central portion of the site. It is bound by placed fill material including a gravel footpath. The wetland was assessed as a flats HGM class and a saturated palustrine emergent (PEMB) Cowardin class. Hydrology is driven by groundwater and the impoundment of precipitation within the topographic depression. The vegetation community was dominated by meadow foxtail and tall fescue, interspersed with reed canarygrass.

### C. SIGNIFICANT NEXUS DETERMINATION

**A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.**

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** The site is 5.61 acres on tax lot 800 on Washington County Tax Map 1N230CD. The site is located west of Northeast Jackson School Road and North of Hamby Park. A tributary to Glencoe Swale flows offsite to the southwest. Glencoe Swale possesses a bed, banks, and ordinary high water mark and is recognized as a relatively permanent water of the U.S. Glencoe Swale flows into McKay Creek, which flows to Dairy Creek and then the Tualatin River. The U.S. Army Corps of Engineers, Portland District recognizes the Tualatin River as a navigable water to river mile 56.8.

The site contains 0.72 acre of PEM wetlands and a ditch (Ditch 1). Ditch 1 was excavated along the eastern half of the northern property boundary, draining west from a culvert placed under NE Jackson School Road, and covers 0.02 acre. Flow in Ditch 1 was observed dissipating at its western end during wetland delineation site visits by consultants. Drain tiles observed at the terminus of the ditch suggest that water may be moving into subsurface drainage, but the direction and presence of subsurface flow is unknown. The wetland delineation does not show a direct connection between Ditch 1 and wetlands on site.
