### C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

**B. ADDITIONAL COMMENTS TO SUPPORT JD:** This Approved Jurisdictional Determination (AJD) was requested to determine the jurisdiction of a 1.03-acre artificially constructed irrigation pond in the southeast corner of Marion County tax lot 201, which is southwest of the intersection of Auburn Road NE and Cordon Road NE in Salem, Oregon. The pond is the only water within the review area of this AJD (see attached map) and was determined not to be Waters of the U.S based upon its construction in uplands for agricultural use. The 51 FR 41206, 41217 (November 1986) preamble to Section 328.3 describes waters that the U.S. Army Corps of Engineers will generally not consider to be Waters of the U.S., including "(c) artificial lakes or ponds created by excavating and/or diking dry land to collect and retain water and which are used exclusively for such purposes as stock watering, irrigation, settling basins, or rice growing." The pond within the review area fits this description as it was constructed for agricultural purposes.

The pond is lined, rectangular in shape, and constructed between 1982 and 1985 based upon aerial photography. Water from the pond was used to irrigate crops and later as settling pond as part of a mushroom farming operation. The pond is not located in soils mapped as hydric by the NRCS soil survey. The pond is approximately 30 feet from an unnamed tributary to Fruitland Creek and associated riparian wetland. The tributary, located outside of the review area, flows along the southern border of the property and then north along the east side of the pond. Historic aerial photos show that the pond was not constructed in the location of the tributary and is not an impoundment of the tributary.
