C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The only potential aquatic resources identified within the Review Area is the North Hoffman Road Ditch and the South Hoffman Road ditch, which are located on each side of Hoffman Road. Other aquatic resources in the vicinity of the Review Area, such as Wetland 1, are located south and outside the Review Area boundary for this Approved Jurisdictional Determination.

The portions of the North Hoffman Road Ditch and South Hoffman Road Ditch within the boundaries of the Review Area each measure approximately 420 long, 3 feet deep and 2 feet wide at the bottom. Each ditch within the Review Area currently flows through one culvert to allow property access from Hoffman Road.

The topography in the Review Area is generally flat with a gentle slope to the west. Any water in the ditches flows from east to the west. Information on the presence or location of culverts under Hoffman Road that may connect flow between the North and South ditches is not available. Water in the North Hoffman Road Ditch and South Hoffman Road Ditch would flow into an unnamed drainage area approximately 660 feet east of the Review Area. The unnamed drainage flows south into Ash Creek. If water in the North Hoffman Road Ditch and South Hoffman Road Ditch is not intercepted by the unnamed drainage, the water would flow east into North Fork Ash Creek.

Based on available information, the North Hoffman Road Ditch and South Hoffman Road Ditch were constructed in uplands as part of the road design. The ditches are not relocated streams and are not RPWs. The ditches exhibit ephemeral flows which directly responds to rain events and carries flows from uplands, the road, and surrounding vicinity.

In accordance with the December 8, 2009, guidance regarding Clean Water Act jurisdiction, agencies will generally not exert jurisdiction over ditches (including roadside ditches) excavated wholly in and only draining uplands and that do not carry a relatively permanent flow of water. The North Hoffman Road Ditch and South Hoffman Road Ditch meet this category of aquatic resource as described above and are non-jurisdictional waters.
