Roadside Ditch/Swale	611	linear feet	(b)(10) Stormwater control feature constructed or excavated in upland or in a non-jurisdictional water to convey, treat, infiltrate, or store stormwater runoff.	The ditch was constructed in the late 1980's to convey stormwater runoff from Air Cargo Road and 82nd Avenue. The water is conveyed through a series of subsurface storm pipes that eventually discharge into a treatment facility to the south of the review area. Based on historic topographic maps and aerial images the ditch did not relocate a tributary and it was constructed in uplands or non-jurisdictional features.
