- The review area is comprised entirely of dry land (i.e., there are no waters or water features, including wetlands, of any kind in the entire review area). Rationale: The Review Area is within the Fort Rock basin, an endorheic features which does not allow hydric outflows to other external bodies of water such as rivers or oceans. The delineation did not identify any wetland indicators such as wetland hydrology, hydric soils or hydrophytic vegetation nor any surface water features.
