PEM wetland is a palustrine emergency wetland that abuts a roadside ditch located to the east of the wetland outside of the Review Area. The roadside ditch is located along the west side Stafford Road. There is no evidence that the ditch relocated a tributary, was constructed in a tributary, or was constructed in an adjacent wetland. Therefore, the ditch does not meet the definition of (a)(2) Tributary. The PEM wetland does not abut an (a)(1)-(3) water, and there is no evidence the wetland is inundated in a typical year by an (a)(1)-(3) wetland. Furthermore, this wetland is not separated from an (a)(1)-(a)(3) water only by an artificial structure allowing a direct hydrologic surface connection between the wetlands and the (a)(1)-(a)(3) water in a typical year. Wetland 4 does not meet the definition of adjacent wetland under the NWPR.
