Ditch 1 is located in the north western portion of the Review Area. Based on aerial imagery and historical topographic maps, there is no evidence that indicates the ditch is a relocated tributary, was constructed in a tributary, or was constructed in an adjacent wetland; therefore, the ditch meets the (b)(5) exclusion pursuant to the NWPR.
