C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The review area is approximately 3.79 acres. The wetland delineation was conducted on January 19, 2021.

Site topography generally slopes from east to west, with site elevations ranging from approximately 140 feet in the western portion of the site, along the base of NW Cornelius Pass Road, to approximately 175 feet within the eastern reaches of the site. A section of McCarthy Creek enters the southwestern portion of the property, where it flows to the north, exiting the subject site at the northwestern portion of the property, and continues to flow offsite to the north. A tributary to McCarthy Creek enters the site in the southeastern portion of the property, where it continues to flow in a northwesterly direction through the northern portion of the property, and eventually flows into McCarthy Creek in the northwestern portion of the property. In addition to McCarthy Creek and its tributary, four wetland areas (Wetlands A – D) are located along the creek and tributary.

The ordinary high water (OHW) of McCarthy Creek and its tributary were also delineated based on guidelines outlined in the Department of State Lands Removal Fill Guide and the U.S. Army Corps of Engineers Regulatory Guidance Letter 05-05: Field Indicators of OHW. Evidence of OHW included scour marks within the creek and tributary, changes in sediment characteristics and vegetation, and exposed roots.

Wetlands A (0.02 acre), B (0.14 acre), C (0.10 acre), and D (0.08 acre) are palustrine emergent-persistent, seasonally flooded wetland (PEMIC). Wetland A, in the northeastern portion of the site, is connected to the north side of the tributary to McCarthy Creek; Wetland B, in the west-central portion of the site, is located at the southeast intersection of McCarthy Creek and its tributary, and is connected to the east side of McCarthy Creek and the south side of its tributary; Wetland C, located in the south-central portion of the site, is connected to the southeast side of McCarthy Creek at its south end, Wetland C continues offsite to the south of the study area; and Wetland D in the northwestern portion of the site, is connected to the northwest side of McCarthy Creek at its north end, Wetland D continues offsite to the north of the study area. Saturated soils and a high water table were often observed in these areas. Dominant vegetation within these areas included colonial bentgrass, common velvet grass, creeping buttercup, and reed canarygrass. The wetland soils met criteria for redox dark surface and depleted matrix, and hydrology consisted of a high water table, saturation, drainage patterns, and geomorphic position. The Hydrogeomorphic (HGM) classification for Wetlands A - D is Slope.

A section of McCarthy Creek (0.15 acre) flows into the southwestern portion of the site, and continues to flow to the north, where it exits the northwestern portion of the site. As previously mentioned, a driveway crosses over the south end of McCarthy Creek. The creek crossing consists of a bridge, with no culverts, that spans the creek and is located above ordinary high water (OHW). A tributary to McCarthy Creek (0.11 acre) flows in an east to west direction, across the northern portion of the site. The tributary enters the site at the southeastern corner of the property, flows to the northwest, then to the west; at its west end, in the northwestern portion of the site, it joins McCarthy Creek. The Cowardin classification for McCarthy Creek is riverine upper perennial unconsolidated bottom permanently flooded wetland (R3UBH), and for the tributary it is riverine upper perennial unconsolidated bottom semipermanently flooded wetland (R3UBF). The HGM classification for McCarthy Creek and its tributary is Riverine Flow-through (RFT).
