The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). avenue, and flows to the southeast toward a apartment complex known as The Village and into a ditch north of SW Borders Street. This ditch flows to the east and into Ash Creek. USGS maps Ash Creek as a perennial tributary on the 2020 topographic map. Ash Creek flows into Fanno Creek, from there the water flows into the Tualatin River and into the Willamette River.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Draw connections between the features documented and the effects on the TNW, as identified in the *Rapanos* Guidance and discussed in the Instructional Guidebook. Factors to consider include, for example:

seasonally: The Corps review Google Map Street Views at the downstream connection of the remnant ditch and SW 90th avenue. Surface water was visible in the January 2016 images as well as the May 2019 image. Utilizing the Antecedent Precipitation Tool (APT) the Corps determined that conditions in January 2016 were wetter than normal and conditions in May 2019 were normal conditions. Based upon the above information the remnant ditch would flow seasonal during the wet season under normal rainfall years.

The Corps review Google Map Street View images of ditch during January 2016, under wetter than normal conditions and no surface water present was within the ditch. The ditch was not constructed within a tributary nor did it relocate a tributary. Based on the Corps review the ditch was constructed to capture surface water flow of Hall Boulevard. The ditch is considered to be a ditch constructed wholly in uplands and draining wholly uplands and therefore is not considered a water of the U.S. The roadside ditch is 0.02 acre.
