C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Wetland 1 is a palustrine emergent wetland located south of Fruitland Creek along the eastern edge of the Review Area. The wetland is located in a shallow concave surface on the gently sloping terrace that grades to the south bank of Fruitland Creek. Wetland 1 is considered reasonably close to Fruitland Creek, refer to Section III D 5. Flow path and distance to the Willamette River is documented above. Fruitland Creek is an RPW that has perennial downstream flow to the Willamette River carrying nutrients to support biota within the TNW. Wetland 1 and similarly situated wetlands along Fruitland Creek would function to trap and filter pollutants as well as act to store flood waters during major flooding events.

Wetland 6 is separated from a stormwater swale via a man-made berm. This swale was constructed within a wetland under Corps Permit No. NWP-2009-48 and is located outside of the Review Area. In accordance with the City of Salem Open Data – Utilities Map, the stormwater swale enters a ditch located along Gaffin Road and flows to the northwest passing through 3 manholes and approximately 0.89 mile (as measured by Google Earth) to the West Middle Fork Little Pudding River. West Middle Fork Little Pudding River is an RPW and flows 3.07 miles to north and flows into Fruitland Creek (Confluence is near end of NE Cottonwood Street). Fruitland Creek continues flowing north approximately 2.56 miles to the Little Pudding River (Confluence north of NE Lardon Road). From here the Little Pudding River flows to the Pudding River, which flows into the Molalla River, which flows into the Willamette River which is the nearest TNW approximately 23.7 miles downstream. The ditch is vegetated with cattails and reed canary grass in segments and sparsely vegetated in other segments of the ditch. Vegetation within ditch did display matting down and bent over in segments. The culvert crossings within the ditch are perched and there are scour marks on the downstream

side of the culverts. Within the culverts, sediment deposits depicted the ordinary high water mark. During the wet season, Wetland 6 would have a hydrologic connection through the ditch downstream to the Willamette River. The ditch and Wetland 6 during the wet season would carry pollutants and nutrients downstream to the West Middle Fork Little Pudding River which is an RPW and those pollutants and nutrients would be indirectly carried downstream to the Willamette River. The ditch and Wetland 6 does have more than a speculative and insubstantial nexus downstream to the Willamette River.

Based upon the significant nexus findings in Section III C, Wetland 6 would carry pollutants to the nearest TNW.

Ditch: This roadside ditch is located along the south side of Culver Drive Southeast. The ditch continues along Culver Drive Southeast until it discharges into Fruitland Creek. The ditch exhibited slowly flowing water during March, by May contained no surface water. The ditch is considered a Non-RPW flowing less than 3-months per year. Water flows during high precipitation events and hydrology inputs are primarily stormwater collection and conveyance systems as well as runoff from adjacent roadways. Scour marks, wrack deposits, or erosion lines were not observed within the ditch. Based upon historic aerial photos the ditch was excavated in uplands. Ditches excavated in uplands, draining uplands, and carrying non-RPW flow are not considered waters of the United States.

Wetland 4 is a palustrine emergent wetland occupying a low terrace in the northwest corner of the Review Area. Based on review of topography maps and Oregon Department of Geological and Mineral Industries Lidar there are rises in topography between the wetland and the surrounding waters. There are no surface water drainage features between the wetland the nearest aquatic resource, which is the non-RPW ditch to the north. There are no man-made berms between Wetland 4 and the ditch. The wetland is approximately 120 feet to the ditch and 1,125 linear feet to Fruitland Creek. The sources of hydrology are primarily precipitation and a ground water table documented at 16-inches during the delineation March 9, 2021. Only during the utmost extreme events would the non-RPW top its banks and overflow within the wetland and vice versa. The mapped soil is Amity Silt Loam which is a non-hydric soil. There is no floodplain designation for the area and based upon the type of soil within the area there is no shallow subsurface connection. Wetland 4 is an isolated wetland.

Wetland 5 is a palustrine emergent wetland occupying a low terrace in the northwest corner of the Review Area. There are no surface water drainage features between the wetland the nearest aquatic resource, which is Fruitland Creek. There are no man-made berms between Wetland 5 and the Fruitland Creek. The wetland is approximately 180 linear feet to Fruitland Creek. The sources of hydrology are primarily precipitation and a ground water table documented at 12-inches during the delineation March 9, 2021. Only during the utmost extreme events would the Fruitland Creek top its banks and overflow within the wetland and vice versa. There is no floodplain designation for the area and based upon the type of soil within the area there is no shallow subsurface connection. Wetland 5 is an isolated wetland.
