C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Wetland 1 measures 0.008 acres and is located in a depression which ends at the gravel shoulder of SW Pendleton Street. The wetland is a function of stormwater runoff from a stormwater pipe which discharges onto the site from the freeway to the west. The stormwater pipe is located near I-5 to the west of the site and the discharge has created a narrow aquatic feature which has formed Wetland 1.

The closest storm drain is approximately 200-feet from the site when following the path on the gravel road and paved street. Any surface water flowing from the wetland would flow onto the gravel road and pavement and eventually into the storm drain. The stormwater system in this area is a combined stormwater/sewer system. There is no indication of berms other than the edge of the gravel road adjacent to the wetland between this wetland and the downstream water. Wetland 1 is at an approximate elevation of 89 feet. The Willamette River (TNW) is at approximate elevation 8 feet and is the nearest water. The Willamette River is approximately 1,600 feet to the east of the site. The source of hydrology for the water is the freeway above the site. The nearest water of the US, the Willamette River, would not overflow into the wetland during extreme flood events. Only under extreme conditions would the wetlands waters overflow into the Willamette, the water from the combined stormwater/sewer system would have to overflow into the Willamette River. The land between the wetland and Willamette River consists of paved roads, residential, and commercial districts. Soils onsite are mapped as 19E: Haploxerolls, steep, 2%, Hydric Inclusions and 53B: Urban Land-Quafeno complex, 3-8% Slopes, 2% Hydric Inclusions. The wetland is not within a Floodplain, or the FEMA 100 Year Flood Zone. There is no indication of a subsurface connection between the wetland and the TNW. A water table was observed within one soil plot at a depth of 8 inches, saturation was present at a depth of 0-10 inches in two plots.

The wetland lacks an interstate commerce connection. It is located on private land. It would not be used by interstate or foreign travelers for recreational or commercial purposes. It does not contain habitat or resources of special significance, nor would it attract birds or wildlife of special significance for viewing by travelers. The wetland does not produce silviculture, agriculture, fish, or shellfish which are sold in interstate transactions.
