C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Wetland D is a slope wetland located approximately 265 feet from the nearest other waterbody. Vegetation within Wetland D consists of velvet grass (*Holcus lanatus*, FAC), colonial bentgrass (*Agrostis capillaris*, FAC), and soft rush (*Juncus effusus*, FACW). Vegetation within the adjacent upland consists of sweet vernal grass (*Anthoxanthum odoratum*, FACU), velvet grass, tall false ryegrass (*Schedonorus arundinaceus*, FAC), and colonial bentgrass. The service road east of Wetland D does not have a culvert which prevents any hydrologic connection with other waterbodies. Wetland D does not abut another aquatic resource, nor does it have an unbroken surface or sub-shallow surface hydrologic connection to another aquatic resource. Wetland D is not separated by a man-made berm or dike, and the wetland is not reasonably close to a relative permanent waterway or non-relative permanent waterway. West of Wetland D 223rd avenue, there are no aquatic resources immediately adjacent to the road. The primary hydrology factors for Wetland D are precipitation and surface flow from surrounding upland areas. Wetland D occurs in 1B Aloha silt loam and 25D Latourel loam. Both are non-hydric soil. Only during the most extreme events would the wetland transmit sheet flow into another waterway as it is separated by developments, roads, and upland areas. There is no evidence to suggest Wetland D supports interstate commerce. The Corps has determined Wetland D to be isolated.
