C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Per the City of Medford, Oregon's Stormwater Management Plan dated February 2005 and accessed via <https://www.medfordoregon.gov/files/assets/public/public-works/engineering/documents/master-plans/stormwater-management-plan-2005.pdf>, the Corps' has determined Elk Creek is a heavily modified perennial tributary to Bear Creek, which is a perennial tributary to the Rogue River. Wetland 1 directly abuts Elk Creek, a RPW, west and outside of the Review Area. The Rogue River is recognized as a Traditionally Navigable Water (TNW) and is on the Corps' Portland District 1993 list of Navigable Riveways within the State of Oregon. The Corps recognizes the Rogue River as a TNW from the mouth of the Pacific Ocean to Agness, Oregon at river mile 27.1. The entire Elk Creek system has been extensively modified and incorporated into the City's stormwater management system. Elk Creek is mapped at the Review Area location on the 1954 and 1978 USGS Medford Quad maps.
