C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Ditch 2: This is a roadside ditch is located along the north side of State Street. The ditch exhibited flowing water during the rainy season. The ditch is considered a Non-RPW flowing less than 3-months per year. Water flows during high precipitation events and hydrology inputs are primarily stormwater. Scour marks, wrack deposits, or erosion lines were not observed within the ditch. Based upon historic aerial photos the ditch was excavated in uplands. Ditches excavated in uplands, draining uplands, and carrying non-RPW flow are not considered waters of the United States.

B. ADDITIONAL COMMENTS TO SUPPORT JD:

The Review Area is located near the intersection of 44th Ave NE and State Street in Salem, OR, Tax Lots 700, 800, 900, 1000, 1100, and the right of way. The Review Area is 1.85 acres and includes five residential homes located. The topography of the Review Area is generally flat with two roadside ditches located on the southwestern and southern Review Area boundary. The limits of the RPW on site is based on the observations of an ordinary high water mark and depictions of flow Google Street View depicts surface water in November within the Wetland Ditch while Ditch 2 remains dry. Images from April 2021 show water in the Wetland Ditch. The feature has surface water from November to April making it a seasonal RPW. Ditch 2 is a non-RPW ditch excavated in uplands draining uplands and non jurisdictional.
