C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

F. NON-JURISDICTIONAL WATERS, INCLUDING WETLANDS (CHECK ALL THAT APPLY):

Ditch 1 is an irrigation ditch (known as Lateral C which connects to the Pilot Butte Canal). Ditch 1 is non-tidal and was excavated in uplands. Non-tidal drainage and irrigation ditches excavated in uplands are generally not considered waters of the U.S. Ditch 1 is the primary source of hydrology for Wetlands 1, 2, 3, and Pond 1. A review of topographic maps, LIDAR data, and historic aerial images indicate there is no return ditch connecting Ditch 1 to any downstream surface waters.

Wetlands 1, 2, 3, and Pond 1 are isolated wetlands due to a lack of hydrologic connection to any waters downstream. The nearest identifiable Water of the U.S. is the Deschutes River. The Deschutes River is located approximately 1.5 miles west-southwest of this wetland complex. The Review Area consists of a dry, sagebrush-steppe ecosystem and there are no indications that these features could overflow over 1.5 miles to the Deschutes River. Wetlands 1, 2, 3, and Pond 1 are located within the "Deschutes-Stukel complex" and "Licksillet-Rock outcrop complex", which are both described as "well drained" soil series. The Review Area is not located within a floodplain. Wetlands 1, 2, 3, and Pond 4 do not contain remarkable habitat, wildlife, or special significance which would attract interstate or foreign travel, nor do they contain resources which could be taken or sold in interstate or foreign commerce.

Ponds 2, 3, and Wetland 4 are isolated wetlands due to a lack of hydrologic connection to any waters downstream. The primary source of hydrology for these features is from an offsite drainage ditch known as "Lateral F" which is non-tidal and excavated in uplands. The nearest identifiable Water of the U.S. is the Deschutes River. The Deschutes River is located approximately 2.25 miles west-southwest of the Review Area. The Review Area consists of a dry, sagebrush-steppe ecosystem and there are no indications that these features could overflow over 2.25 miles to the Deschutes River. Ponds 2, 3, and Wetland 4 are located within "Stukel-Deschutes-Rock outcrop complex" soil, which is described as a "well drained" soil. The Review Area is not located within a floodplain. Ponds 2, 3, and Wetland 4 do not contain remarkable habitat, wildlife, or special significance which would attract interstate or foreign travel, nor do they contain resources which could be taken or sold in interstate or foreign commerce.

Ditches 2, 3, 4, and 5 are shallow swales that are fully vegetated and exhibit no signs of relatively permanent flow and exhibit no wetland parameters. None of these ditches continue beyond the Review Area boundary.

Pond 4 is an existing lined, recycled water storage lagoon utilized by the City of Redmond. Wastewater is treated in a municipal activated sludge wastewater treatment plant and sent to this pond. Pond 4 water is then used as a source for the adjacent pivot irrigation system within the Review Area. The entire wastewater storage system is permitted by the Oregon Department of Environmental Quality (DEQ) as a component of the City's Water Pollution Control Facility (WPCF) permit. WPCF permits are issued by DEQ for discharges of wastewater with no discharge to surface waters, such as land irrigation systems. Pond 4 is an isolated water due to the absence of any surface drainage features between it and the Deschutes River, which is located approximately 2 miles west of the feature. Water in Pond 4 is treated and used as irrigation water for the adjacent pivot irrigation system, which is located within "Stukel-Deschutes-Rock outcrop complex" soil, which is described as a "well drained" soil. The Review Area is not located within a floodplain. Pond 4 does not contain remarkable habitat, wildlife, or special significance which would attract interstate or foreign travel, nor does it contain resources which could be taken or sold in interstate or foreign commerce.

Pond 5 is a depressional feature located to the southeast of Pond 4 and is an isolated wetland due to a lack of hydrologic connection to any waters downstream. The nearest identifiable Water of the U.S. is the Deschutes River. The Deschutes River is located approximately 1.5 miles southwest of the Review Area. The Review Area consists of a dry, sagebrush-steppe ecosystem and there are no indications that this feature could overflow over 1.5 miles to the Deschutes River. Ponds 5 is located within "Stukel-Deschutes-Rock outcrop complex" soil, which is described as a "well drained" soil. The Review Area is not located within a floodplain. Pond 5 does not contain remarkable habitat, wildlife, or special significance which would attract interstate or foreign travel, nor does it contain resources which could be taken or sold in interstate or foreign commerce.
