C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

The primary hydrology source for the Wetland 1, Wetland 2, and Wetland 3 is precipitation supplemented by local runoff from adjacent upland developments. The closest aquatic resource to the review area is Munsel Creek which is located approximately 300 feet to the east of the review area and is separated from the review area by residential development and a residential street. A stormwater line runs north to south along the eastern review area boundary and discharges directly into Munsel Creek to the east of the review area. The nearest intake to the stormwater line is located approximately 120 feet to the north of the review area and is 1-2 feet higher in gradient than the review area. Wetland 2 extends slightly beyond the northern boundary of the review area but is still greater than 100 feet from the nearest intake to the stormwater line. Wetland 1 and Wetland 3 are located even further from the intake and 1-2 feet lower in gradient than the intake. As a result, it is unlikely that would it be possible for the wetlands in the review area to transmit sheet flow into Munsel Creek via the stormwater line. There is no evidence to suggest that Wetland 1, Wetland 2 or Wetland 3 support interstate commerce. The Corps has determined that Wetland 1, Wetland 2, and Wetland 3 are isolated waters.
