C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). - Hopkins canal was constructed circa 1910 to divert water from Fish Lake and the headwaters of the North Fork of Little Butte Creek for irrigation purposes. The Corps reviewed a historic U.S. Geological Survey (USGS) topographic maps from 1893 along the entire alignment of Hopkins Canal. There is no evidence that the canal was constructed within a water of the U.S. The 1893 map does not show blue line streams within the Review Area and historic aerial images are not available prior to the canal's construction. While the canal was constructed in uplands, it does not drain only uplands. The canal still diverts water

from Fish Lake and the headwaters of the North Fork of Little Butte Creek for irrigation purposes. In addition, the Corps previously issued an approved jurisdictional determination that an an unnamed perennial tributary (water of the U.S), drains into the canal near Webfoot Drive in Medford, which is approximately 0.25 mile south of the Review Area. The National Wetlands Inventory (NWI) has also recorded palustrine emergent wetlands immediately adjacent to the canal near Amy's Place in Medford, which is approximately one mile to the south of the Review Area.

- Surface water levels in Hopkins Canal are controlled by the Medford Irrigation District. The channel conveys water used for irrigation in the dry season and collects incident rainfall in wet season. Goodle Earth Pro aerial imagery from August 2018 shows surface water in the canal during the dry season. Surface water was also noted during the wetland delineation survey on August 26, 2021. While there are no aerial images of the Review Area during the wet season due to cloud cover, the 30-year normal for precipitation from November through May in the area is 20 inches (Oregon State University (OSU), 2022). Based on the high frequency and magnitude of rainfall events in the Review Area, the Corps determined that surface water would be present in the canal during the wet season. The Corps determined that its flow regime is perennial because there is water in the canal during the entirety of a normal year.
- Hopkins Canal possesses a hydrologic connection through surface water and culverts with Upton Slough. Upton Slough possesses a hydrologic connection through surface water with the Rogue River near Tolo, Oregon. The Rogue River is a listed on the Portland District 1993 list of navigable riverways within the State of Oregon as a navigable water of the U.S. to river mile 27.1.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Sample points installed ladnward of the OHWM of the canal during the August 26, 2021 wetland delineation survey do not indicate that hydrophytic vegetation, hyridic soil indicators, or wetland hydrology indicators are present in this area. Uplands in the Review Area are dominated by cheatgrass (Bromus tectorum) and Medusahead (Teaneantherum caput-medusae), both of which have an upland indicator status. In conclusion, there are no wetland features in the Review Area.
