C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Wetland A and B are similarly situated and have similar hydrologic inputs. Wetlands A and B will be described together. The wetlands are palustrine emergent seasonally saturated wetlands occupying a low terrace north of Shaff Rd SE. Based on a review of topographic maps and LIDAR there is a rise in topography between the wetlands and Salem Ditch, which is located outside of the Review Area. Google Earth images also show no signs of connection, surface water drainage features between the wetland and nearest RPW. The wetlands do not possess a direct or indirect hydrologic connection to Ditch I. The sources of hydrology are primarily precipitation and a ground water table. The mapped soil is Clackamas gravelly loam which is a non-hydric soil. The wetlands are located approximately 0.27 miles from the nearest RPW. Only during the most extreme events would the nearest RPW over-top its banks and overflow within the wetlands. The project is in an area of minimal flood hazard. Wetlands A and B are isolated wetlands.

B. ADDITIONAL COMMENTS TO SUPPORT JD: The review Area is located at the intersection of Shaff Road and Golf Club Road in Stayton, OR (Township 9 South, Range 1 West, Section 4, portions of Tax Lots 1500, 1600, 1601, 1700 and Road Rights of Way (ROW); Township 9 South 1 West, Section 9B, portions of Tax Lots 100, 101, 102, 600; and Section 9AB, portions 5901, 6000, and Road ROWs. The Review Area is 3.95 acres and includes the intersection and road right of ways of Golf Club Road SE and Shaff Road SE. The study area and surrounding lands are nearly flat .
