Potentially jurisdictional waters and/or wetlands were assessed within the review area and determined to be not jurisdictional. Explain: Wetland A and Wetland B are depressional palustrine emergent wetlands that are located on historic farmland and their primary hydrology source appears to come from precipitation. Wetland C is a palustrine wetland that occurs within a roadside ditch located along James Street.

The closest surface drainage feature to the review area is Abiqua Creek to the northwest of the review area. There are no apparent surface drainage features between the wetlands in the review area and Abiqua Creek. Abiqua Creek is located approximately 1,750 feet from the review area and is approximately eight feet lower in elevation than the review area but separated by rural agricultural, residential, and transportation developments. No natural berms are present between Abiqua Creek and the review area, but the review area is bound by rural streets and a railroad right-of-way. The primary hydrology source for Wetlands A and B is precipitation and Wetland C (a roadside ditch) also receives runoff from James Street.

It is not likely that water from Wetlands A, B, and C would overflow into Abiqua Creek even during extreme flood events. The land between the review area and Abiqua Creek has been historically used for agricultural production and provides only low-quality habitat for wildlife use. Soils in the review area are moderately well drained, but Wetland A occupies an area of poorly drained soil. The review area is in an “Area of Minimal Flood Hazard” according to the Federal Emergency Management Agency National Flood Hazard Layer and there is no evidence of a surface connection via culvert and no evidence of a shallow subsurface connection to Abiqua Creek based on Corps review and information provided by the requestor. There is no evidence to support that Wetland A Wetland B, and Wetland C would support interstate commerce. The Corps has determined that Wetland A, Wetland B, and Wetland C are isolated waters.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

B. ADDITIONAL COMMENTS TO SUPPORT JD: Email coordination was sent to EPA and Corps Headquarters on 24 January 2022. Corps Headquarters responded on 25 January 2022 that they had no comments on the review and the coordination was complete. EPA responded on 02 February 2022 with concurrence that Wetlands A, B, and C were isolated, non-jurisdictional waters.
