B. CHARACTERISTICS OF TRIBUTARY (THAT IS NOT A TNW) AND ITS ADJACENT WETLANDS (IF ANY):

This section summarizes information regarding characteristics of the tributary and its adjacent wetlands, if any, and it helps determine whether or not the standards for jurisdiction established under *Rapanos* have been met.

The agencies will assert jurisdiction over non-navigable tributaries of TNWs where the tributaries are “relatively permanent waters” (RPWs), i.e. tributaries that typically flow year-round or have continuous flow at least seasonally (e.g., typically 3 months). Powells Butte and the Crooked River. The nearest RPW is the Crooked River located approximately 3.3 miles east of the Review Area. The Crooked River flows generally north and west for approximately 41 miles before joining the Deschutes River at The Cove Palisades State Park. From there, the Deschutes River flows 86 miles north until it empties into the Columbia River at Celilo. The Columbia River is a navigable waterway.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

All streams delineated within the Review Area (ST 01-11) exhibit non-RPW, ephemeral flow regimes that dissipate within a geologic terrace between Powells Butte and the Crooked River. The Review Area is located within this flat terrace. The nearest RPW is the Crooked River, which is located approximately 3.3 miles east of the Review Area. Remote tools including Oregon Department of Geology and Mineral Industries (DOGAMI) Lidar, historic USGS topographic maps, USGS StreamStats raindrop mapper, and historic aerial images do not indicate there are any surface hydrological connections between the subject streams and the Crooked River. Sheet flow from these streams would need to travel 3.3 miles before reaching the Crooked River. Therefore, the Corps can conclude these streams do not carry pollutants, flood waters, nutrients, or organic carbon to the Crooked River. These streams flow in response to rain events and do not provide habitat or lifecycle support for fish and other species. In conclusion, Streams ST 01-11 do not have effects on the physical, chemical, or biological integrity of the Columbia River.

- If potential wetlands were assessed within the review area, these areas did not meet the criteria in the 1987 Corps of Engineers Wetland Delineation Manual and/or appropriate Regional Supplements.

Explain: As discussed above, streams ST 01-11 are non-RPW, ephemeral drainages as documented within the Pacific Northwest Streamflow Duration Assessment Methods (SDAM) datasheets included within the wetland delineation. These ephemeral streams did not display any vegetation or benthic indicators of relatively permanent flow. The closest RPW to the Review Area is the Crooked River, located approximately 3.3 miles east. This distance, combined with the other factors discussed above, indicate that none of ephemeral streams within the Review Area have a significant nexus to the Columbia River.
- Other: (explain, if not covered above): Aerial imagery, historic topographic maps, and information from the property owner indicate that WET 01 and WET 02 are livestock watering ponds excavated in uplands. The 1988 United States Geological Survey (USGS) map indicates a well in the approximate location of WET 01. Livestock ponds excavated in uplands are typically considered “preamble waters” and are not waters of the U.S. The two wetland ponds have no hydrologic connection to downstream TNWs.
