C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Hydrology is received from precipitation and pipe flow, of which the source is unknown and appears to convey only seasonal flow. There is no outflow from the pond to a downstream tributary. Based on historic topographic maps the pond is an artificially constructed pond created in dry land to collect or retain water. The ornamental pond is a water meeting the definition of a preamble water which are generally not considered waters of the United States.

Wetland A is located along a slope in the western Review Area. Hydrology is received from precipitation, groundwater, and overland flow that concentrates along the non-forested area of the grass field. The Cowardin classification is palustrine emergent. The nearest mapped waterway is approximately 1,237 feet to the east with a potential unmapped non-RPW waterway located approximately 440 feet to the west. There are residential developments and a road to the east, while west of the wetland is a forested area. There are no defined topographic surface water drainages that would allow outflow from the wetland to another waterbody. Only during the most extreme events would the wetland overtop and sheet flow to the unmapped waterbody to the west. The soil map identifies Cornelius and Kinton silt loams with 2 to 7 percent slopes. The drainage class is moderately well drained and is considered a hydric soil. The capacity of the most limiting layer to transmit water is 0.06 to 0.2 inch per hour. Wetland A is not located within a mapped floodplain nor is there evidence of a shallow subsurface connection. Wetland A has been determined to be an isolated water.

Wetland B is located in a small depression east and upslope of Wetland A. Hydrology is received from overland flow and precipitation that gets trapped in the small depression. The Cowardin classification is palustrine, emergent. Wetland B is in a similar location as Wetland A. The nearest mapped waterway is approximately 1,237 feet to the east with a potential unmapped non-RPW waterway located approximately 440 feet to the west. There are residential developments and a road to the east, while west of the wetland is a forested area. There are no defined topographic surface water drainages that would allow outflow from the wetland to another waterbody. Only during the most extreme events would the wetland overtop and sheet flow to the unmapped waterbody to the west. The soil map identifies Cornelius and Kinton silt loams with 2 to 7 percent slopes. The drainage class is moderately well drained and is considered a hydric soil. The capacity of the most limiting layer to transmit water is 0.06 to 0.2 inch per hour. Wetland B is not located within a mapped floodplain nor is there evidence of a shallow subsurface connection. Wetland B has been determined to be an isolated water.

Both wetlands are palustrine emergent and located on private property there is no evidence to suggest that these wetlands are used to support interstate commerce.
